WWD Responsibilities:

- ▶ Rotovate for weed control prior to planting
- ▶ Offer plastic mulch for all plantings
- ▶ Will provide basic weed control consisting of mowing between rows twice in year of planting
- ▶ May refuse to plant if site is not prepared
- ▶ May secure protection agreement and assume associated costs

Landowner Responsibilities:

- ▶ Provide access for staking, planting, weed control & inspection
- ▶ Shelterbelt site must be cultivated
- ▶ Supply additional weed control as necessary
- ▶ Place marker stakes supplied by WWD at planting site
- ▶ Protect plantings from livestock, chemical or fire damage
- ▶ Must allow for protection agreement to be placed on plantings
- ▶ Dispersal of any unused trees ordered by landowner
- ▶ Purchase trees through WWD Tree program or other source

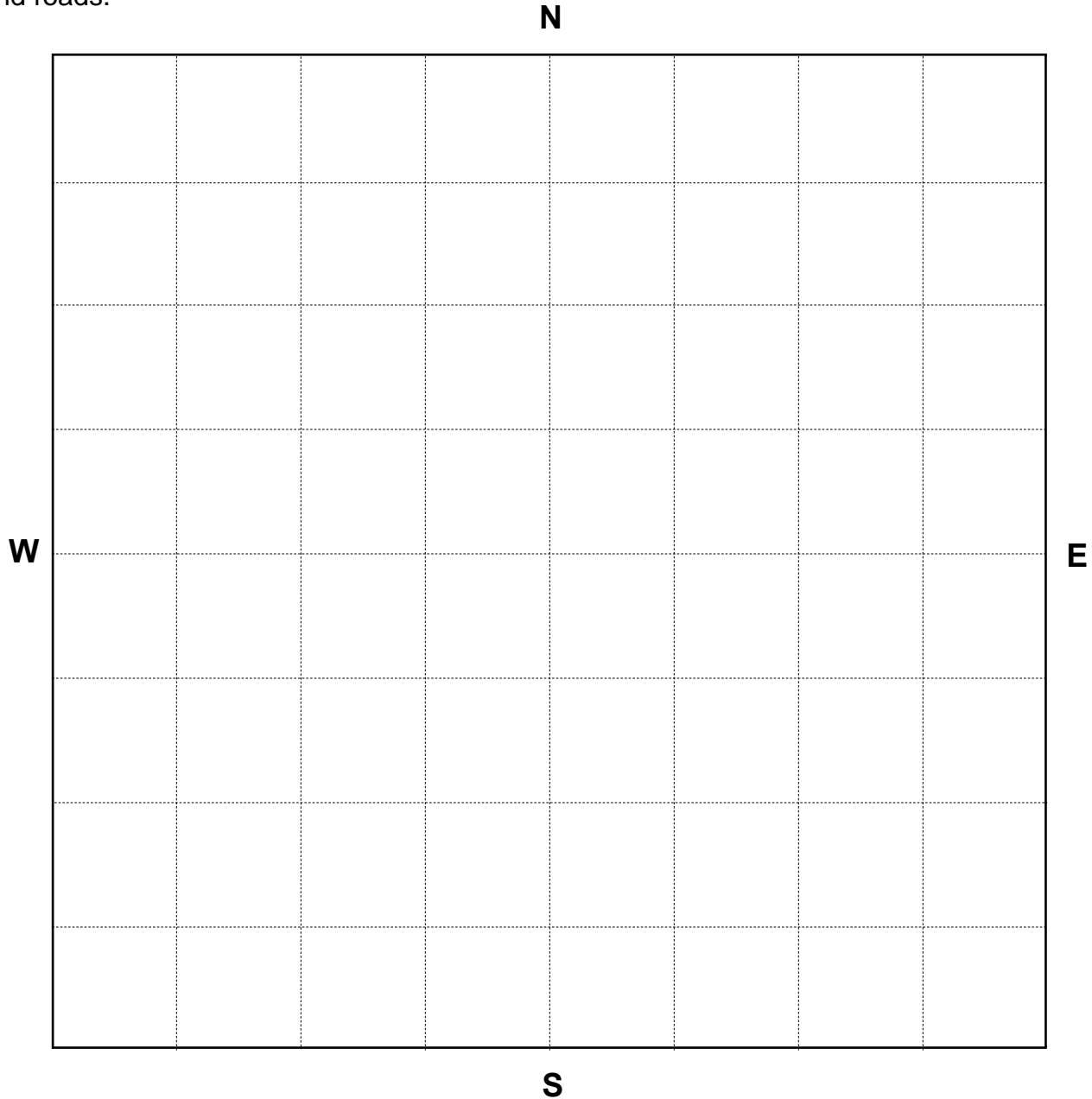
- ▶ Will plant replacement trees if landowner has purchased them provided weed control was selected for original planting
